

## **Resources for Background Checks on Prospective Tenants**

**Warning:** There is a possibility of facing a discrimination claim if you maintain a blanket policy of rejecting prospective tenants who have any kind of criminal history. To avoid problems, you should carefully study the post titled "Using Criminal Records to Screen Housing Applicants" on our blawg.

You should check court records for the prospective tenant's possible criminal and/or civil litigation history. It should be a red flag if the tenant has been evicted by other landlords. You can also consider obtaining a credit report on the prospective tenant. If you obtain a credit report and decide to reject a prospective tenant at least partly on the basis of the credit report, you must provide the tenant with a "Statement of Credit Denial." See Form 3 on the Forms page.

### **Internet Access to Criminal and Civil Court Cases**

1. Go to the following web page: <https://www.courts.mo.gov/casenet/base/welcome.do>
2. Select the search method you desire at the top of the page. On the next page select the desired Circuit (Boone County is in the 13th Circuit) and enter as much information as possible to narrow your search.
3. If your search criteria match any case records, you will see a list of one or more matching cases.
4. Click on the case number of any case you want to review.
5. On the next page you will have several choices to view information about the case. Usually selecting "Docket Entries" will give you the most information in one place.

Note: For Boone County, you will receive the same information via the Internet as you can obtain by viewing the computerized records on a terminal at the Circuit Clerk's office.
